# Board of Education Meeting December 7, 2019 Work Session

#### **Financing Update**

Treasurer Fouke provided a financial update pertaining to the passage of the Bond/Operating Levy and the process required to secure funds from the levy. The first step in this process is to select a Municipal Advisor, requests for proposals (RFPs) have been requested and the deadline for submission is December 9, 2019. The final decision will be made by December 16, 2019.

Mr. Fouke provided further information to the Board on district finances as the district will receive approximately \$3 million from the Operating Levy, however due to the State freezing State-Aid and now we have EdChoice, our cash balances really have not changed from May 2019 and through the next three years. Mr. Fouke will be providing updates to the Board and district regarding finances in the next few weeks.

## **OFCC Update**

Dr. Anstadt along with Mr. Ilstrup, Mr. Hughes, Mr. Merritt, Mr. Fouke met with the OFCC representative Eugene Chipiga and Regency Construction Services representative Scott Wagner to discuss the next steps regarding the district rebuild. The meeting discussion consisted of the following:

Toledo Clinic Update – The bid opening will be held on December 17, 2019. The construction estimates came in higher than anticipated, however the architect believes these were bid conservatively and actual costs shall be less than budgeted.
